Severe One-Vehicle Rollover Accident Near Dunning Sends Four To The Hospital

A one-vehicle rollover accident on Memorial Day sent four to the hospital, three with critical injuries.

According to the Nebraska State Patrol, on Monday, May 27 at approximately 11:15 AM, a 2002 Honda was traveling westbound on US Highway 91 at mile marker four east of Dunning when the driver, 28 year

old Brooke Bennet from Green Valley, Arizona, lost control of the vehicle. The Honda left the roadway on the right side of the highway rolling multiple times which also ejected three juveniles, ages 7, 9, and 11, from the vehicle.

Two of the juveniles were taken by medical helicopter in critical condition to a Kearney hospital, while Bennet was

taken by medical helicopter to a North Platte hospital also in critical condition. The third juvenile was taken by ambulance to a North Platte hospital with injuries.

No fatalities have been reported. Alcohol is suspected in the cause of the accident.

The accident is under investigation by the Nebraska State Patrol.

The Mustang is the 15th raffle car produced by

Former Stapleton Village clerk faces charges

Amy Allen, former Stapleton Village clerk-treasurer, is facing three counts after an arrest was made at 6:30 p.m., Wednesday, May 29.

Allen turned herself in at the Logan County Sheriff's office in Stapleton, after an arrest warrant was issued following an investigation by the Nebraska State Patrol and an attestation report completed by the Nebraska State Auditor.

Allen posted ten percent of a \$25,000.00 bond and she was released after being taken to the Custer County jail where she was booked and charged with theft/deception of \$5,000 plus, abuse of public records, and public official/misuse of property/funds.

The first charge is a Class IIA felony which carries a minimum of 0-20 years imprisonment. The other two charges are misdemeanors, each carrying up to six months in jail or a fine of up to \$1,000, or both.

Allen resigned her position with the village in August of 2018 to take a position as office clerk in the Logan County Clerk's office. She had worked as village clerk for 10 years.

On January 22, 2019, the APA received a letter from a concerned citizen alleging the mishandling of public funds by Ms. Allen during her tenure as the former clerk/treasurer. Specifically, the complaint alleged the following:

"From what I have heard is that the former clerk-treasurer (Amy Allen) has signed a paper with the Village of Stapleton Board agreeing to repay the village \$15,000.00 in exchange

for no charges being filed against her. The main concern that I have is that Amy Allen is now employed for Logan County and is working in the clerk's office."

On February 28, 2019, the APA contacted the Village regarding that allegation. In response, the APA received a copy of the Settlement Agreement between the Village and Ms. Allen.

During September 2018, discrepancies were discovered with Village utility customer accounts, as amounts received by the previous clerk had been applied to different customers.

During October and November, 2018, MJK CPA conducted an analysis to determine how much money appeared to have been misappropriated by Ms. Allen.

The Village board was presented a summary of Ms. Kramer's analysis at the Village Board's meeting, alleging the theft of Village funds by Ms. Allen. The board moved to go into executive session at that meeting to discuss the findings and came out of executive session with no action taken.

Chairman Bryan Rooney and vice chairman Dan Beckius sought legal advice from village attorney, Mike Borders.

Chairman Rooney and vice chairman Beckius and Ms. Kramer met with Ms. Allen on January 2, 2019. They provided her with a copy of an agreement drawn up by the Village attorney, asking her to repay \$15,000 over time. The agreement was signed by Ms. Allen and Chairman Rooney.

The board of trustees voted to accept Allen's restitution at the February 21, 2019 meeting.

The APA traveled to the Village on April 24-25 and obtained various financial documents, including invoices, billings, receipt books, and other supporting Village records. The

APA also received bank statements provided in support of the Village's denied audit waiver request.

Allen provided a written statement to the Nebraska State Patrol, admitting her misappropriation of Village funds. During an interview she admitted to deleting from the Village's accounting system the invoices of customers who paid fees with cash.

The State Trooper investigating the allegations reported to the APA that Allen claimed she did not take any monies from customers paying with a check. Allen's practice was to delete the invoice in relationship to the customer whom was paying with cash only.

The APA ran a QuickBooks voided-deleted transactions summary report from September 1, 2013, to the present and observed over 800 deleted customer transactions. The report totaled \$38,290.88 of deleted transactions, but the clerk may not have taken cash for every deleted invoice; however, based on the deleted transaction report, it appears likely that she took well over the \$15,000 agreed upon.

The APA found only one receipt book dating back to March 2018.

Other findings in the auditor's report were a number of issues with the Village's internal control processes, village employees were not required to pay utility fees while working for the Village, and those amounts were not taxed as a fringe benefit; the Village's utility billing issues included not updating relevant ordinances, not billing for water usage, and not ensuring that all customers were properly billed for services received; there were several issues with the Village's payroll processes; and the Village's handling of claims
