
Greene is District Winner

The annual Shell Science Lab Challenge Competition recognized outstanding middle and high school programs for their exemplary approaches to science lab instruction utilizing limited school and laboratory resources. The Challenge showcased the work of teachers, representing their schools, who submitted innovative, replicable strategies to deliver quality lab experiences with limited equipment and resources, and awarded teachers and schools with additional tools, resources, and rich professional development opportunities needed to support high-quality science teaching and strengthen their existing capabilities.

Zeta Greene's high school science department's mission statement is: "Life is a Journey. Education is the roadmap and compass." Science inquiry serves this mission by using research-based instructional strategies—such as active learning, group-based assessment, and organizational methods—to solve problems, analyze results, and communicate results with peers. Inquiry activities might include testing an insulated thermos for retention of hot and cold temperatures. Using probes to analyze data can help students answer these questions that affect their everyday life. Using the Shell science lab award, Mrs. Greene is planning to use the money to install an updated chemical fume hood, eye wash station and add some testing equipment to the classroom that would facilitate teacher and student integrations during lab work time. Having a laboratory upgrade will help ensure that labs at multiple levels can be used to encourage student understanding of impactful science, maintain safety, and help bridge the gap in experimental knowledge from high school to college.

The science department received a \$3,000 grant for improvements to the science room,

Mrs. Greene is a graduate of Sandhills High School and is in her third

Nebraska Voters To Receive Early Ballot Request Application



Secretary of State Bob Evnen has decided to mail an early ballot application to every registered voter whose county did not already do so. The effect will be every registered voter in Nebraska will receive an early ballot request application in the mail.

"For voters who have concerns about voting at the polls in November, an early ballot request for a mail-in ballot is a good option," said Secretary of State Bob Evnen.

"Anyone who wishes to vote early should request their ballot as soon as possible."

The first ballots will be mailed out September 28.

The deadline to request an early ballot to be mailed to you is October 23.

USPS recommendation for returning your early

ballot by mail is October 27.

The deadline for early voting in person in the County Clerk/Election Commissioner's office is November 2.

Voters who requested early ballots must return them to the County Clerk/Election Commissioner's office by the close of the polls November 3.

Voters also have the option of going to the polls to vote. The polls will be open for the General Election, November 3. County officials and the Secretary of State are taking precautions to protect the safety of voters and poll workers.

Schaeffer Injured In Farm Accident Near Stapleton

Stapleton area fire and rescue personnel were called to a farm accident at Steve and Sally Schaeffer's, located at 29 Avenue 80, west of Stapleton, Thursday, August 20, at approximately 3:27 p.m.

Responding to the call were Stapleton Fire & Rescue, Logan County Deputy, Dalen Wood, McPherson County Sheriff, Tom Burch, a Nebraska State Patrol investigator who is also a paramedic, North Platte paramedics, and LifeNet

A tractor had become stuck and a payloader was being used to pull the tractor out. A log chain gave way and broke, going through the back window of the payloader occupied by Matt Schaeffer of Stapleton, striking him in the back of the head.

Fire & EMS worked to remove Schaeffer from the payloader and LifeNet Services was able to land 300 yards from the scene. They were not able to transport, and North

Platte paramedics took Schaeffer from the accident to Great Plains Health in North Platte. He

was taken on to UNMC in Omaha where he was scheduled for surgery on Friday, August 21.
