'21 Logan County Open Class Fair & Rodeo Underway

The Logan County Fair open class and rodeo events will get underway Thursday, August 19. Open class entries will be taken from 10:00 a.m. until 2:00 p.m. at the Logan County Fair Building. The exhibit hall will be open after judging for viewing. Exhibits should be picked up Sunday, August 22 between noon and 2:00 p.m.

There are three candidates vying for Logan County rodeo queen and include Haylee Dimmitt, Lacie Benell, and Natalie Newman. Pictures of the girls may be found inside this issue on page 11.

The contest was held Friday, August 13, and the coronation will take place Friday, August 20, at the Logan County Fairgrounds prior to the ranch rodeo.

The ranch rodeo has been moved from Sunday to Friday, August 20, and buckles will go to the winning 4-man team. A breast collar will be awarded to the top horse, sponsored by Wild Horse Creek Ranch.

Check-in is at 5:00 p.m. and the rules meeting at 5:30 p.m. Cowboy introductions will take place at 6:00 p.m. and the queen coronation will follow.

Events are doctor-mugging, sorting, trailer loading, and trailer race.

Admission is \$5.00 per car.

A multitude of activities are scheduled for Saturday, August 21.

The 12th annual Stapleton Stampede, Kids 1 Mile & 5K will get underway at 7:30 a.m. Eric Kloke is this year's chairman and participants should meet at Live Fit Gym located on Highway 92.

The pork breakfast will be served from 8:00 a.m. until 11:00 a.m. at the Logan County Fairgrounds.

Rodeo slack will begin at 8:30 a.m. at the fairgrounds and after enjoying breakfast, everyone is encouraged to watch cowboys and cowgirls compete in the arena.

The Logan County Fair & Rodeo archway and gates have been re-installed at the fairgrounds. The N.S.R.A., M.S.R.A. and open rodeo will get underway at 7:30 p.m. There will be bareback riding, saddle bronc riding, steer wrestling, calf roping & 45 and over calf roping, barrel racing, breakaway roping, bull riding, team roping and mixed team roping.

A horse boot race will be part of the rodeo fun.

The Matt Schaeffer Memorial pony race and wild horse race will be held at the conclusion of the rodeo.

Eric Garrels was contacted and admitted he had struck the pole with his 2013 Dodge Ram 2500 pickup. Garrels was cited for failing to report an accident. No injuries were reported.

Garrels will appear in Logan County Court, September 14.

Survey shows yes to limiting dogs

A recent Village of Stapleton survey showed an overwhelming majority of residents wanting to see the two dog per household restriction put back in place.

The village board changed the dog ordinance in 2018 and took off the two dog limit. Board members agreed to conducting a survey to see if the limitation should be put back into place, as there have been increasing calls of bark-

ing dogs and animals running at large within the Village limits.

There were 41 people in favor of limiting the dogs and 20 voted no.

The village board voted to amend Ordinance No. 213-18-1 at their regular August meeting.

Village residents are reminded if you currently have more than two dogs in your household, you are grandfathered in and nothing will change. You can continue to have

more than two dogs.

Residents are also reminded dogs may not run at large and must be licensed with proof of rabies vaccination at the time of licensing.

No person shall own, keep or harbor any dog which annoys or disturbs any neighborhood or person, by loud continued or frequent barking, howling or yelping, or chases pedestrians, horses, other livestock or any vehicle, while on the public side-

walks, streets, alleys, avenues, or byways.

A complete copy of the ordinance may be viewed at the Village Hall.

Banner County Fire Burns Thousands Of Acres

Thousands of acres burned have burned since the start of the "Hackberry Fire" that ignited around 7:00 p.m., Thursday, August 5, southeast of Harrisburg in Banner County.

Fire departments and agencies from across the state, as well as neighboring states, worked together to fight the fire. Stapleton, Thedford, Arnold, and Callaway were among those assisting. Fire Chief Frank Kramer said Stapleton sent one truck and three personnel. They left around noon Friday and returned to base around 2:00 p.m. Saturday. Two Nebraska Army National Guard UH-60 Blackhawk helicopters were on the scene. Governor Ricketts declared a state of emergency in Banner County.
