

## Logan County couple arrested after high speed chase

Two Logan County residents are in custody after a high speed pursuit and drug bust that began in Lincoln County and ended in Logan County.

Lincoln County Deputy Tiffany Wood attempted a traffic stop of a Washington State plated white Impala at approximately 2:10 p.m., Monday, September 13 at mile marker 97 on U.S. Highway 83. The car did not stop and continued northbound on Highway 83 reaching speeds of over 100 miles per hour. The vehicle passed three to four vehicles at a time and nearly caused head-on accidents. The vehicle turned onto Hodges Road, entered Logan County and the pursuit continued on Avenue 80. The suspect could be seen throwing out bags of property.

Joseph Duran, 36, of Stapleton, was eventually stopped one half mile south of Highway 92 on Avenue 70 where he was taken into custody.

Lincoln County Deputy Sheriff, Derek Hanna, spotted a person in a gray mini-van with Washington plates picking up one of the bags and taking off with it.

Logan County Sheriff Sean Carson stopped the gray mini-van and consent was requested to

search the vehicle. The driver was Alissa Duran, 36, of Stapleton. The search revealed a black bag containing 15.5 ounces of marijuana.

The Lincoln County Sheriff's office and Nebraska State Patrol also found two more bags containing four ounces of methamphetamine.

Alissa Duran was arrested and jailed in Custer County for aiding and abetting a felony, tampering with evidence, and possession of marijuana over one ounce and less than one pound.

Duran was arrested by the Lincoln County Sheriff's office and jailed in Lincoln County. He was charged with flight to avoid arrest, willful reckless driving, possession with intent to distribute methamphetamine, possession with intent to distribute marijuana, and tampering with evidence.

Stapleton Fire & Rescue was called to assist at the scene.

Evidence was used to secure a search warrant of the Duran residence located at 56 Avenue 70, Stapleton, and Logan and Lincoln County officers, the Nebraska State Patrol and Nebraska State Patrol bomb squad found a homemade pipe bomb located in the home, along with several pounds of marijuana, and a 2019 stolen Ranger utility vehi-

cle out of Washington State. The Nebraska State Patrol bomb squad rendered the pipe bomb safe at 3:30 a.m. Tuesday

morning, September 14. The investigation is ongoing and additional charges may be filed on both suspects.
