



## Logan County Drug Busts

A supervised child visitation led to the arrest of a Valentine woman in Logan County. Health & Human Services scheduled a visit and a case worker notified the Logan County Sheriff and reported an incident at Cornerstone Evangelical Presbyterian Church that money was missing and marijuana had been detected.

Logan County Sheriff Sean Carson and Deputy Dalen Wood went to the church and consent was given to search a bag where methamphetamine and cash was discovered.

Tanya Lee Wingrove of Valentine was arrested for theft and possession of a

controlled substance.

She will appear in Logan County Court on Tuesday, September 13.

A traffic stop on Highway 92 near the Logan-Custer County line led to the arrest of two people.

Deputy Dalen Wood stopped a Budget rental truck for driving left of center, Tuesday, August 23.

Contact was made with Sir-Maree Antron Wallace, driver of the truck, and Salem Matar, a passenger. The two were headed out of Colorado to Minnesota with the moving company.

It was found Wallace was a fugitive from justice in Buffalo and Cheyenne counties. He

was charged with carrying a concealed weapon and possession of THC concentrate.

Matar was found to have THC concentrate in his possession.

The two were booked at the Lincoln County Detention Center, North Platte, and will be in Logan County Court, September 13.

The rental truck was put into storage at the Stapleton Fire Hall where a search warrant was obtained and a search conducted last Friday. Leaf marijuana, THC concentrate and psilocybin mushrooms were found in the contents of the truck.
