

## New sprinklers going in at Golf Course

The Thedford Golf Course has been working towards replacing all the fairway sprinklers at the course.

They completed two on their own, but with the increasing costs of supplies they decided to reach out for grant assistance on the remaining seven.

The association replaced three more fairways this September and would like to recognize the two foundations helping them with this project by awarding them grants.

The Mid-Nebraska Foun-

ation in North Platte approved a \$5,000.00 grant to help with the project and the Thedford Area Community Foundation approved the organization for a \$2,500.00 grant.

Sandhill Oil of Thedford installed the sprinklers and donated the labor to help keep costs down so the project would be cost effective.

The project will be completed next spring with the remaining four fairways receiving new sprinklers.

## Schultis/Zutavern Nominated For Homecoming Royalty

A fire broke out around 1:30 p.m. on Sunday afternoon, October 2, in the Nebraska National Forest near Halsey. It's believed to have originated from a ATV.

The Region 26 Deputy Emergency Manager says between 5,000 to 6,000 acres had burned as of Sunday evening and was not contained at that time.

The Nebraska State 4-H Camp made this announcement on their Facebook page on Sunday afternoon, October 2.

"We have received word that a forest fire in the Nebraska National Forest caused major devastation at our camp. The Eppley lodge as well as the cabins are a complete loss; it appears that the only structure remaining is the staff house. All of those on site were safely evacuated."

The wildfire, which has been named Wildfire Bovee, and as reported on the Nebraska National Forests & Grasslands Facebook page, was estimated to be 15,000 acres as of 7:30 p.m. Sunday, October 2. The fire had jumped the North Loup

River, BNSF Railroad tracks and Highway 2 just west of Halsey about 1.5 miles and continued in a north/northwest path across rangeland. The Village of Halsey and the campgrounds at the Bessey Ranger District were evacuated.

Highway 2 was closed shortly after the fire began and remained closed between Thedford and Halsey on Monday morning. Classes were cancelled at both Sandhills Elementary and High School, as the schools were being used for centers to supply firemen as well as any evacuees that needed housed.

Fire departments from all over central and western Nebraska, as well as Forest Service firefighters and air support from multiple large and single-engine air tankers, were fighting the fire.

Resources from South Dakota State Wildland Fire and the Black Hills National Forest were also mobilized, including a dozer.

More will be reported on this fire in next week's paper.
