Public Feedback Sought On R-Project Transmission Line Crossing Portion Of Sandhills In North-Central Nebraska

On November 18, 2022, the U.S. Fish and Wildlife Service (Service or FWS) published a Notice of Intent in the Federal Register and opened a 30-day public scoping period, beginning November 18, 2022, and ending December 18, 2022, to prepare a Supplemental Environmental Impact Statement (SEIS) under the National Environmental Policy Act (NEPA) for an anticipated incidental take permit (ITP) application associated with the R-Project Impact Statement (SEIS) under the National Environmental Policy Act (NEPA) for an anticipated incidental take permit (ITP) application associated with the R-Project transmission line.

Nebraska Public Power District (NPPD) is preparing a revised habitat conservation plan (HCP) in support of NPPD's anticipated ITP application to authorize take of the federally threatened American burying beetle that may result from construction and operation activities associated with the proposed 226-mile long, 345-kilovolt transmission line in north-central Nebraska.

The SEIS will evaluate the impacts related to the

proposed issuance of the ITP and implementation of the revised HCP, including addressing the issues identified by the U.S. District Court for the District of Colorado in its 2020 remand of the previous ITP that the FWS issued on June 12, 2019.

The Service is seeking feedback during the public scoping period on the effect of the potential action on the human environment, including the issuance of a permit authorizing incidental take of a covered species in association with covered activities, and revised Habitat Conservation Plan implementation. Input received during the scoping period will be incorporated into the draft SEIS.

How to Participate in Public Meetings:

The U.S. Fish and Wildlife Service (FWS) will host two virtual public scoping meetings on December 8, 2022, at 10:00 a.m. and 6:50 p.m. CST.

links to the virtual meetings will be posted on the project website the day prior.
