A vacancy exists on the Thomas County Board of Commissioners after the resignation of John Seeley effective November 30, 2022. Seeley sold his ranch in Thomas County and is relocating out of the county. Thomas County Clerk, Lorissa Hartman said letters of interest for the position are being taken at this time. State Statute requires the County Attorney, County Treasurer, and County

Clerk appoint a commissioner to fill the vacancy. Seeley was re-elected and Lewis Herbaugh elected to the board at the November general election. Pam Moody is the other Thomas County Commissioner. Seeley's term runs through January of 2028.

Over 350 people were in attendance at the Sandhills Fire Relief fundraiser held November 11 at the Thomas County Fairgrounds Event Center.

There were silent and live auctions, a Facebook auction, and donations collected at the door and it has been reported over \$100,000 was raised to help local ranchers and local fire departments who responded to the Bovee Fire on October 2 that started in the Nebraska National Forest near Halsey.

More than 18,000 acres of forest and private land was burned in the blaze.

Ranchers not only lost their pasture, but fences, and their winter feed source.

Some of the money will go to the Nebraska Cattlemen Disaster Relief Fund. Relief applications will be taken until December 31, 2022. Membership with Nebraska Cattlemen is not required for an application.

Proceeds raised at the fundraiser will also be distributed to six local fire departments that responded to the fire and includes Anselmo, Dunning, Halsey, Purdum, Brewster, and Thedford.
