Blaine County Area Community Foundation Making An Impact



The Dunning Community Hall was built in 1938 by the Works Progress Administration under the Roosevelt Administration following WWII. It is a beautiful stucco structure with a pine interior and oak floor. The building has been used for many events including weddings, basketball games, dances, craft shows, and "picture shows." Currently, Sandhills Public Schools utilizes the hall for Sandhills-Thedford Knights wrestling as well as award banquets. The Blaine County Area Community Foundation has been a proud supporter of the Dunning Community Hall. Three Nebraska Senators sponsor bills to help western NE

Western Nebraska state senators are working hard for this part of the state and are sponsoring bills to help rebuild the Nebraska 4-H Camp in the Nebraska National Forest near Halsey, move the headquarters for the Game and Parks Commission to Sidney, and level the playing field to open the door to interests for proposed racinos in North Platte, Ogallala and Gering after Nebraska voters amended the state constitution in 2020 to allow casinos at horse tracks.

State Senators Mike Jacobson of North Platte and Tom Brewer of Gordon have co-sponsored a bill to steer \$30 million in state help toward rebuilding the Nebraska 4-H Camp near Halsey.

LB 281 would set aside \$50 million for "any qualifying nonprofit organization for building or renovating youth outdoor education camp facilities."

District 42 now includes Thomas County and is in Senator Jacobson's district. District 43 Senator Tom Brewer's district included all of the forest before the redistricting and includes Blaine County. The Nebraska Department

of Economic Development would process the grant funding.

Senator Brewer and Senator Jacobson recently attended a meeting between the University of Nebraska, the 4-H Foundation and the U.S. Forest Service. These three organizations share overlapping jurisdiction of the camp. Discussion at the meeting included a number of innovative ideas brought up by the group and included a public-private partnership to help ease the burden on taxpayers.

Senator Steve Erdman will introduce a bill to move the headquarters for the Nebraska Game and Parks Commission to Sidney.

Senator Erdman said moving the headquarters to Sidney would be advantageous for western Nebraska and it would put the commission right where they need to be.

"Current state law says the headquarters for the Game and Parks Commission has to be at Lincoln, but having the headquarters at Lincoln makes little sense, especially when it comes to wildlife. There is very little wildlife in the city of Lincoln, so those who work for the commission seldom ever encounter the same kinds of

problems with wildlife that we see in western Nebraska," Erdman said.

Erdman said state parks in western Nebraska do not get the same kind of special treatment that state parks get in eastern Nebraska. Mahoney State Park offers glamping, an aquatic center, an indoor playground, a treetops rope course, an observation tower and an indoor rock-climbing wall.

Erdman said these kinds of amenities at our western state parks are not available.

"The fact of the matter is that the camping fees collected at state parks in western Nebraska end up getting used to spruce up state parks on the eastern side of the state and that's not right."

In addition moving Game and Parks would give an added boost to Sidney's economy.

Erdman introduced a similar bill in 2021. However, LB562 never advanced out of committee and was indefinitely postponed at the end of the session.

"Because it often takes several years to get a good bill passed into law, I will try again," Erdman said.

Senator Jacobson has also introduced Legislative Bill 148 which would overrule lawmakers' 2022

decision to delay new horse track casino combinations until after completion of a statewide market analyses and an impact study.

Last year's LB 876 put a moratorium on considering new racino locations while Nebraska's six existing horse tracks added casinos.

Jacobson said now that casino gambling has been approved in the state you can drive to Grand Island, 150 miles away from North Platte and leave your money there and they get all the property tax relief.

Jacobson's bill will help open the door to west central and western Nebraska without a lengthy delay. Communities from Grand Island east have been allowed to participate in statewide initiative that has a property tax reduction component and supporters say it will give western parts of the state the same opportunity as is available in eastern Nebraska.

Race tracks have been proposed at North Platte, Ogallala and Gering. The bill would also extend the deadline for the racinos' completion from 2025 to 2030 and let regulators potentially approve new horse racing licenses in the state.
