Neal Lumber changes hands

After Sandy Larsen took over the Doyle and McMillan Lumber Yard in Thedford, he tore out the old storage sheds and built new storage for lumber and supplies as this picture shows in the *Pictorial History of the Sandhills*. The Larsens operated the business for 40 years and in 1975 sold it to Tim and Kenneth Neal, who formed Neal Lumber Company, Inc.

A lumber company that has been in the same location for well over 100 years is changing hands.

Tim Neal is announcing the sale of Neal Lumber Co., Inc. to Dave Masek of Purdum, effective February 10, 2023. Neal Lumber's last day of operation will be Thursday, February 9, and the business will be closed Friday, February 10.

Tim and his father, Ken-

neth Neal purchased the lumber company from Sandy Larsen in 1975.

"I've decided that it's time for me to step down and enjoy retirement," Tim said. "I know that Dave will continue to serve our customers and I will be available to help Dave, or you, if the need arises."

Tim said his family thanks everyone in the area for their support and loyalty over the years.

"We are very thankful

and grateful to have had you as our customer," Tim said.

The history of the lumber yard in Thedford dates back to 1887 when lots on which the store is located were platted and surveyed and recorded in the Thomas County records. Charles Barnes was the original owner.

In 1889, William W. and Delia Cowles became the owners, receiving a warranty deed from the General Land Office during

the administration of President Benjamin Harrison. Mr. Cowles had a printing press and published a newspaper.

During the next few years, owners of the property were M.D. Lyons, followed by Burton and Cyrus Wraughton and later by J.F. Spiker. In the early 1900's, Jim McMillan and John Doyle acquired the property and opened a general store and lumber yard; the store with groceries and general merchandise was in the main building.

Jim McMillan built a

small addition to the west of the main building and operated a bank. This was in addition to running the lumber yard, which he and John Doyle maintained for many years.

They sold everything the homesteaders needed including food, clothing, fence posts, wire, windmills, tanks, horse-drawn mowers, lumber and building supplies. The Doyle and McMillan partnership continued for over 50 years.

In 1935, Sanford and Kathryn Larsen purchased the business and

operated it for 40 years. In 1975, Tim and Kenneth Neal bought it and formed the Neal Lumber Company, Inc.

The original store building is still standing and is being used although it has been remodeled and added to several times.

The very first lumber yard in the Sandhills area was started by Homer Gage at Dunning before the railroad came through the country. He had supplies shipped into Kearney and hauled them over the hills to Dunning by horse and wagon.

our office as soon as possible to ensure cost-share availability. The Upper Loup NRD cost-shares on hand plant orders of at least 100 trees or shrubs, machine planted orders of at least 200 trees/shrubs, and drip line irrigation. Cost-share funds are distributed on first come first serve basis. Contact our office at 308-645-2250 to start your tree plans.

Join Nebraska Extension across West Central Nebraska this spring and attend the "Windbreaks for Livestock and Acreage Savings" class.

Randy Saner, Nebraska Extension Livestock Educator, and David Lott, Nebraska Extension Horticulture Educator, will be teaching this class across the region to help ranchers, farmers, and acreage owners understand the importance of windbreaks as an important tool to help conserve input costs related to livestock operations and utility bills. An emphasis on correct windbreak design, tree and shrub replacement plans, control for eastern red cedar beyond the windbreak, feed and
