Improvements have been made at the library in the way of new furniture, equipment, and computers thanks to grant funding. The library was recently designated as a silver status accredited public library.

Trimble and her husband, Dave, sold their home in Stapleton and moved to North Platte three years ago.

## Village Clean-Up Continues

Clean-up of nuisance properties continues in the Village of Stapleton and the Velazquez/Rivas house has been demolished on E Street. The house had been damaged by fire and had been abandoned. Demolition and clean-up was completed by the village.

The board moved forward with condemnation on the Vicki Allen property. This was in place prior to renters moving in and the health board viewed the property and reported back to the board that the house is not liveable as there is no water or sewer. There is a back lien against the property due to the Village of Stapleton in the amount of \$1,630.55. Two liens have also been placed against the property at the Logan County Courthouse. The condemnation process was also

started on the Russell Lockwood property at the south end of C Street.

The village board held a second reading of the emergency snow route and the peddler ordinance was approved at the regular June meeting.

Sheriff Sean Carson reported a street sign had been stolen, there was a dog incident, a patron was using trash and sewer without payment, a scam was reported, the health board met to discuss condemnation of property, there was a warrant for an individual's arrest, and a dog was reported running down the street unattended.

Velda Cassell requested three Special Designated Licenses for the Vet's Club for street dances on July 7, August 4, and August 19. All three were approved.

Livestock applications for chickens were approved for Bryan

Higgins, Chayton Crow, and Steve and Cindy Frey.

The contract with the Logan County Sheriff was approved with one dissenting vote and there were no changes from last year's contract that runs from July 1, 2023 to June 30, 2024.

A request for more sound proofing in the large room of the Stapleton Community Center was addressed. It was agreed that there would be no way to add sound proofing except by carpeting the room that would cover up the bowling lane wood which makes the room unique.

Board trustees Steve Kramer and Anita Harwager volunteered to help review and work on updating current ordinances.

The yearly review of the clerk was conducted and the board voted unanimously to increase her wage by \$2.00 per hour effective July 1, 2023.

Arnold was one of the stops on the July 6 'Fly-Around' tour as Governor Jim Pille provided the public an opportunity to learn about broadband programs and build out and provide input into digital access, affordability, and need for technical skills resources to create equitable distribution of broadband in the state. Governor Pille re-

cently announced the appointment of Patrick Haggerty as the state's first broadband director. Haggerty will lead the Nebraska Broadband Office established by Executive Order No. 23-02 and LB 683, which will coordinate broadband deployment across Nebraska.

Governor Pille established the Office of the Director of Broadband as part of his executive Cabinet.

K.C. Belitz, Department of Economic Development (DED), and Vicki Kramer, Director of the Nebraska Department of Transportation (DOT) accompanied Governor Pille and Haggerty.
