UN-L team qualifies for nationals

Trinity Hansen, a junior at the University of Nebraska-Lincoln, majoring in accounting with a minor in data analytics, is a member of the University of Nebraska-Lincoln's competitive team qualifying for national competition in January, 2024.

Hansen, the daughter of Travis and Melody Hansen of Stapleton, was invited by her professor to participate as one of the five member team to participate in the 2023 Deloitte FanTAXtic Case Competition, sponsored by Deloitte Tax LLP.

Launched in 2002 and revamped in 2011, the Deloitte FanTAXtic Case Competition features a reality-based case, student team presentations, opportunities for networking with tax professionals and a chance to compete in national competition.

The team put in about 100 hours of practice time preparing for regionals which was held via Zoom on October 27, 2023.

Three hundred students, over 50 colleges, and 62 teams competed in the competition with the top two teams from each of the eight regions

advancing to the National Competition hosted at Deloitte University on January 19-21, 2024.
