

## Two cafes in unincorporated town

Stanley and Shareen Munson are not like most people. While many dream of retirement and sitting on a beach somewhere, the Munsons have taken on not one, but two restaurant businesses to support their community and make it a better place. It's very much out of the norm, but their lives have been anything but traditional.

The 1974 McPherson County High School sweethearts married at 17 and left friends and family for Stanley's military assignment in New Jersey. They later moved to Oklahoma.

Shareen recalls she doesn't know how they got through those early years, but they did. They had four boys in five

years and she says she got along fine without google to look up how many times you need to feed a baby. We just did what we needed to do.

They returned home in 1977 to be closer to Shareen's parents, Chart and Wilma Nicholson and family members.

Stanley recently retired from the railroad after 39 years, four months and 18 days. Shareen began working parttime in the McPherson Co. Courthouse and was elected treasurer in 1995. She served in that capacity until retiring in 2019.

"We were planning to enjoy our retirement years," Shareen said. "Well I guess you could say that didn't last very long."

The couple purchased Aunt Bea's Café in March

of 2020, remodeled the building and changed the name to Prairie Hills Café.

The Munsons agree they did it because there was a need for a cafe to provide jobs and a gathering place in the community. Their thought was get it up and going, show that it could be profitable and have someone buy it. So far they have accomplished the first two feats and are still going.

"People kept asking us to serve alcohol with evening meals at Prairie Hills Café," Shareen said. "We checked into it and we were told by the Nebraska Liquor Commission it was too close to the school so we told people that it wasn't possible. We

## New McPherson County Sheriff Begins Duties

Newly hired K.C. Bang brings a lot of experience to the McPherson County Sheriff's office as he recently began his duties serving residents of the county.

Sheriff Bang attended policy academy and graduated at the age of 19. At one time he was the youngest deputy sheriff in the state of Nebraska.

After starting his career in Wahoo in Saunders County he switched gears and became an arson investigator and K-9 handler.

"My dad was a career fire fighter and I became very interested in fire investigation," Sheriff Bang said. He continues to keep up continuing education for fire investigation and is an EMT.

Sheriff Bang has worked in law enforcement and as an arson investigator for 38 years. In addition to Saunders

County, he has been Chief of Police at Valley, worked arson at Bellevue for 11 years, was a Schuyler police officer and then chief for four years, was a Sheriff Sergeant in Ogallala for four years, and Hooker County Chief Deputy for one year.

Sheriff Bang said he officially retired on paper for four days as an arson investigator before returning to law enforcement. That's what the sheriff's office is here for."

Sheriff Bang has two sons and one daughter and he has one grandson.

He is currently living in Tryon and said taking this position would not have been possible without the support of his family.

"This is something that I really wanted to do. I've worked in the fourth largest law enforcement agency in the state and now I'm at one of the smallest. But you know what? I like that."
