Mulligan Retires After 30 Years With USPS

Judy Mulligan of Thedford has retired after 30 plus years with the United States Postal Service. A retirement party, hosted by her family, was held in her honor May 31 at the Sandhills Corral at Thedford.

Mulligan began her tenure as a clerk in Valentine where she served in that capacity for seven years. She served as postmaster at Kilgore, Hyannis, Thedford, Stapleton, and Mullen, and also worked in South Dakota. Mulligan was an orientation instructor for new hires in North Platte for the last eight years.

"All told I have worked in over 20 offices over the years in Nebraska and South Dakota," Mulligan said. "I will miss the wonderful people in all the communities I served over the years and I've had awesome crews at the post offices."

Mulligan went on to say she now will have more time to spend with her grandchildren and be able to travel.

Valuation Change Notices Mailed Out

Thomas County Clerk Assessor Lorissa Hartman has sent out the 2024 property valuation change notices.

Residential values are figured by using market information. Sales of residential properties are evaluated for the last two years and in those years there has been a very strong real estate market on residential properties in the county.

A complete reappraisal was completed on homes in Thedford, Seneca and Halsey. New costing tables were updated to June 2023 and new depreciation tables were developed using the current sales of homes. Lot values were also increased.

Nebraska statute requires residential sales ratio has to be between 92% and 100%. The level of value has been deter-

mined to be 98% of market value.

Home and building site values increased throughout the county.

A complete reappraisal of all commercial property was completed in 2023 and new costing, depreciation tables and lot/land values were updated.

A list of sales used for residential and commercial properties can be viewed in the Thomas County Clerk's office.

If you feel your assessment does not reflect a fair market value for your property you have the right to protest the 2024 value of your property.

If you choose to file a protest this must be done between June 1 and July 1, since June 30 falls on a Sunday.

Nebraska Statutes require that Ag land sales ratio has to be between 69% to 75% of market value. The sales ratio for 2024 came in at 69%.

A list of sales used during the study period can be viewed in the Thomas County Clerk's office.

If you feel your assessment does not reflect a fair market value for your property you have the right to protest the 2024 value of your property.

If you choose to file a protest this must be done between June 1 and July 1, since June 30 falls on a Sunday.

A good supply of fresh water is essential to human existence. We use fresh water not only for drinking, but for bathing, growing food, cleaning, watering animals and watering lawns. In Nebraska about 95 percent of rural residents get their household water supply from private or domestic wells.

If they are not properly protected, these wells are at risk of being contaminated from several sources.

Potential sources of groundwater contamination which may be present near your home include septic tanks, animal waste, pesticides, fertilizers, fuel storage tanks, household chemicals, used motor oil, etc.

The potential for contamination in our area is also increased because of the sandy soil.

The only way to know if nitrates and/or bacteria are present in your drinking water is by testing because both contaminants are colorless, odorless, and tasteless.

A water test for nitrate is highly recommended for households with infants, pregnant women, nursing mothers, or elderly people, as these groups are most susceptible to nitrates. Coliform bacteria are microscopic, generally harmless organisms that live in the intestinal tract of many warm-blooded animals including humans and are excreted into the environment through feces.

Although most coliform bacteria are not directly disease causing, some are often found with other, more dangerous strains of bacteria like E. coli, shigella and salmonella. Some strains of E. coli are known to cause vomiting, diarrhea, and other serious gastrointestinal problems.

As of January 2023, the

Nebraska Department of Natural Resources (NDNR) listed over 381 domestic wells registered in the Upper Loup NRD the state. Domestic wells

were not required to be registered with the state prior to September 1993,

therefore thousands of domestic wells exist that are not registered with the NDNR.

Unlike public water supplies, the quality of private water sources in Nebraska is unregulated by federal or state mandate.

Thus, well owners are encouraged to have their well water tested and make sure their well is properly maintained to help protect their health and safety.

The Upper Loup Natural Resources District (ULNRD) has had in place a groundwater quality monitoring program since 2011.

All sub-districts are monitored, on a cyclic schedule, for nitrates and upon request
